- c. Discussion and Possible Recommendation on Land Development Use and Regulations
 - 1. Review of Permitted Uses in Central Business (CB), General Commercial (GC), Heavy Commercial (HC), Light Industrial (LI), and Heavy Industrial (HI) Zoning Districts Appropriate for the Entertainment and Cultural District

Ms. Sawyers shared a map showing the recent boundaries established for the Entertainment District and the current Abilene Cultural District.

2. Discussion and Possible Motion to Establish Geographical Boundaries for the Entertainment and Cultural District

Ms. Lynn Barnett, Executive Director of the Abilene Cultural Affairs Council, discussed architectural sculptures to be placed within the entertainment district. One will be placed north of the Civic Center next week.

Additionally, an event is planned for October titled, "Walk This Way," located behind the T&P Depot and pedestrian tunnel where a mural will be unveiled and a sculpture of a flying dragon.

Members of the Task Force also discussed the monthly meetings of the Abilene Downtown Association, which meets the first Thursday of each month. They would like to attend the meeting on September 2, 2021.
